I would also like to give a big shout out for those who stepped up to organize our popular and well-attended fun and competitive tournaments. Through May and June, we ran junior tennis lessons with our volunteer coach, Serene Ford, and her enthusiastic volunteer helpers Sherri Andrews and Remé Cliché. Also, many thanks to the club members who helped out getting the courts ready in the spring and the dedicated crew that kept the clubhouse clean and organized. Special thanks to Anna Cox who kept the lessons program running smoothly, to Yutaka Yoshida for maintaining our well-used ball-machines and to Cheryl McMicken for modernizing our web site. Thanks to everyone for making the 2022 season a success!

Moving onto 2023, as you know our courts are due for a full replacement but we can't proceed until funding and partnerships are completely worked out. I am happy to report that recent discussions with Saanich are encouraging. In the meantime, regular maintenance will be required to address problem spots to ensure the surface is safe to use. We expect a short delay this spring for some minor repair work and more information about this will be communicated. Other maintenance items to address this year will be replacing our water heater, fixing holes in the deck, replacing/fixing the gutter, clearing brush from the parking lot to improve access, and repairing the ball machines. The club is looking for a facilities coordinator who may or may not wish to be a formal board member but report to the board regarding maintenance costs. Please contact me if you are interested in taking on this role.

I am looking forward to working with the 2023 STC board of directors to deliver an equally rewarding year of events and activities. I encourage your participation and if possible, help out to make our club the best little club on the island! As always, your feedback is important to us so please contact me or any of the board members if you have suggestions or recommendations for improvements.

TREASURER'S REPORT

Saanich Tennis Club Annual general Meeting, February 1, 2023 Treasurer's report for Fiscal Year 2022

INCOME & EXPENSES

Net profit for FY2022 was \$6,041 versus \$16,178 for FY2021. The principal reason for the decrease was the court repair work undertaken in in FY2022 amounting to \$10,432 versus \$0 spent on court repairs in FY2021.

Excluding court repairs, the FY2022 surplus would have been \$16,473, with the following breakdown:

- Membership dues and general operating expenses recorded a surplus of \$14,138;
- Events and tournaments generated a surplus of \$155;
- Lessons generated a surplus of \$1,799; and
- Sunday indoor tennis generated a surplus of \$381.

BALANCE SHEET

The Club's assets (in bank and Stripe accounts) increased by \$6,041 during FY2022 and on December 31, 2022 stood at \$52,614. The Club had no liabilities on December 31, 2022. Saanich Tennis Club total equity was \$52,614 on December 31, 2022.

OUTLOOK for 2023

The surplus from membership dues versus operating expenses is expected to increase slightly in FY2023 to \$18,500 (versus \$16,178 in FY2022). Other categories (events, lessons, Sunday tennis) surplus is expected to be approximately the same as FY2022. Budgeting for court repairs is increased for FY2023 to \$13,000, as inflation is expected to increase costs.


MEMBERSHIP REPORT

205 adults registered, 86 of which were new members.


30 Juniors (incl. children in family memberships), 25 of which were new members.
